HIV Knowledge Poll Results (Correct Answers in yellows)

General HIV Knowledge Questions	TRUE	Unsure	FALSE
HIV is MORE easily transmitted during sex than most other sexually transmitted infections.	11.1%	0%	88.9%
A person living with HIV CAN transmit HIV through saliva if there is blood in it.	11.1%	11.1%	77.8%
Oral sex is one of the MAIN ways HIV is transmitted.	11.1%	0%	88.9%

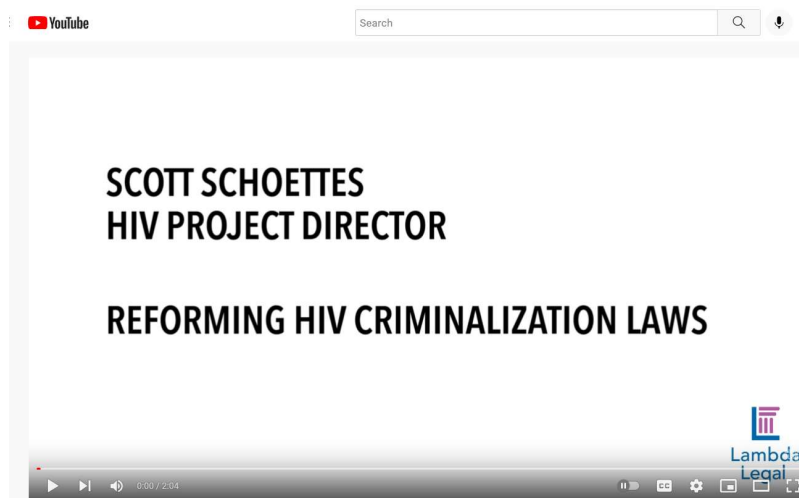

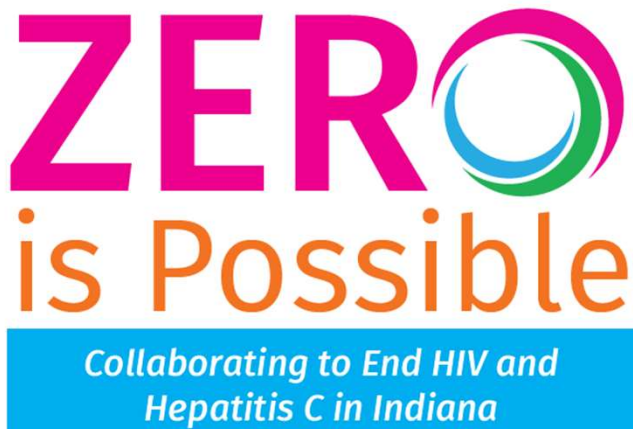

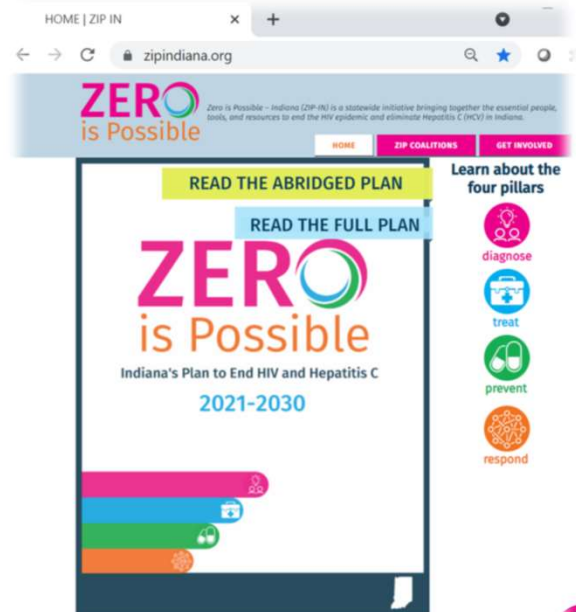

ZIP-IN Aligns with National Goals

The ZIP-IN Plan goals are aligned with the national [Ending the HIV Epidemic plan](#), as well as the [Viral Hepatitis National Strategic Plan](#).

Ending the HIV Epidemic

Reduce **new HIV diagnoses** by 75% in five years and 90% in 10 years

Proposed HIV indicators:

- Incidence
- Diagnoses
- Knowledge of Status
- Linkage to HIV Medical Care
- Viral Suppression
- PrEP Coverage



Proposed HCV indicators and targets:

- Reduce **acute HCV diagnoses** by 20% by 2025 and 90% by 2030
- Increase proportion of people who have **cleared HCV virus** to 58% by 2025 and 80% by 2030
- Reduce rate of **HCV-related deaths** by 25% by 2025 and 65% by 2030

ZIP-IN Plan Goals and Cross-Cutting Strategies



Diagnose all people with HIV & HCV as early as possible



Treat HIV & HCV infections rapidly and effectively



Prevent new transmissions of HIV & HCV by using proven interventions, including PrEP and SSPs



Respond quickly to potential HIV & HCV outbreaks to get prevention and treatment services to people who need them

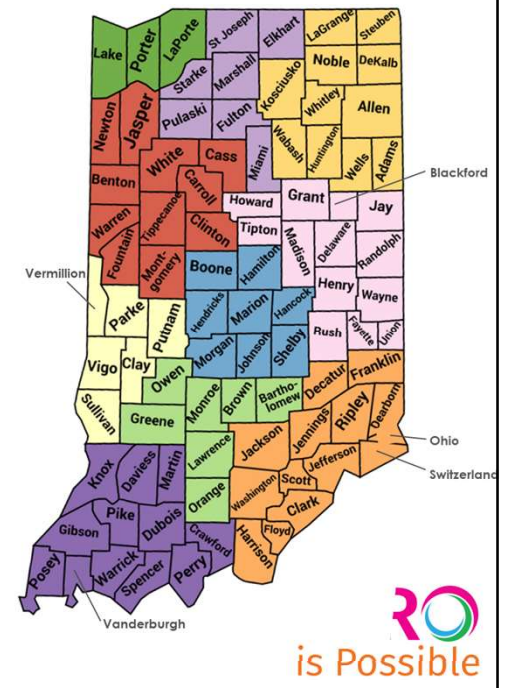
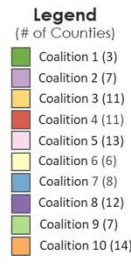

ZIP Coalitions

PROMOTE	Promote a community-wide commitment to the goal of ending the HIV epidemic and eliminating HCV
COLLABORATE	Collaborate with partners to share information, resources, tools, and strategies to diagnose, treat, prevent, and respond
PRIORITIZE	Set regional priorities, assess programs and performance, and provide recommendations for local funding allocation
CENTER	Center the voices of people with lived experience
ENLIST	Enlist diverse partners - promote access to and effective use of mainstream programs

ZIP-IN Plan Leadership and Engagement



IDOH will lead the implementation of the Plan at the strategic level by providing funding, technical assistance and support, evaluation and progress assessments, and communication.

ZIP Coalitions will serve as a coordinated, community-based approach to identifying needs, building a system of supports and services to address those needs, and collectively monitoring progress and working together to strengthen the system to meet the needs of all community members in alignment with the priorities identified in the ZIP-IN Plan.

IDOH and ZIP Coalitions will engage with community partners, healthcare providers, **LHDs** and people living with HIV and HCV to support and strengthen efforts to diagnose, treat, prevent, and respond to HIV/HCV.

Advocates and PWLE have important and meaningful roles to play in the implementation of the Plan, providing expertise and guidance based on their unique perspective and leadership among peers, in their community, and throughout the system of care.

The **Statewide Advisory Council** will provide oversight and guidance for the ZIP-IN initiative.

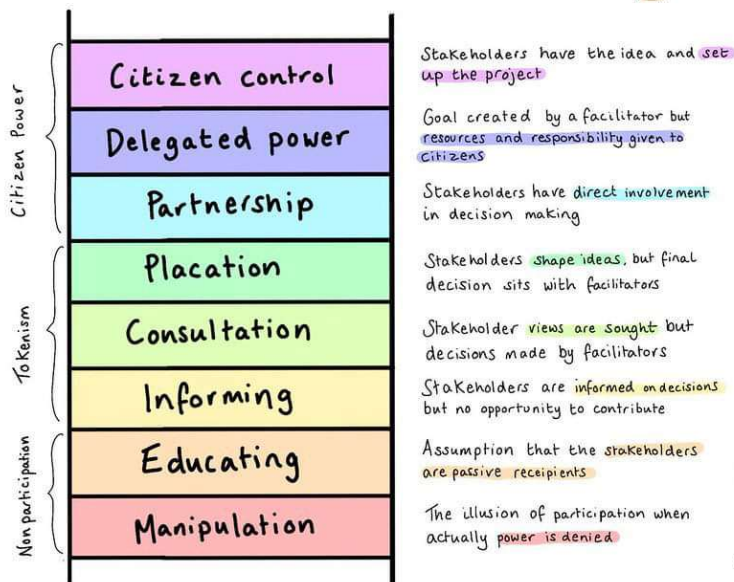

ZIP Coalition Timeline and Goals

Year 1

The focus of year one is relationship-building, knowledge sharing, and adapting and implementing tools for regional documentation.

- Rollout of ZIP-IN Plan
- Revise regional boundaries
- Establish/modify leadership structure, systems, and norms
- Enlist new partners
- Hold quarterly meetings, begin using tools
- Coalitions identify community needs and priorities that inform IDOH's allocation of resources

Year 2

Coalitions are well established and have the tools and supports they need.

- Coalitions and IDOH have shared understanding of roles collaborate effectively
- Regional goals, benchmarks, and priorities are established.
- Coalition members working in alignment (individually) and collaboratively toward shared goals.
- Coalitions identify community needs and priorities that inform IDOH's allocation of resources

Years 3-5

Coalition leadership roles, management, and shared accountability are well established, and agency performance and priorities inform IDOH funding decisions.

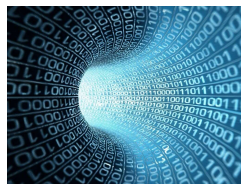
Coalitions review and revise priorities and benchmarks on an ongoing basis and have functional workgroups, cross-sector partnerships, and informed strategic direction.

Coalitions increasingly leverage resources through non-traditional partners and funding sources to meet the needs of all community members.

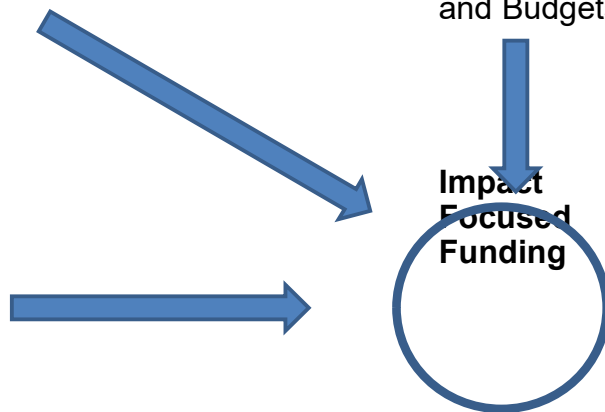

Regional Dashboards

Designed to help IDOH and regional Coalitions identify regional **priorities** and be more **strategic** in **allocation of funds** by providing a **comprehensive tracking tool**.

Agency Scorecards

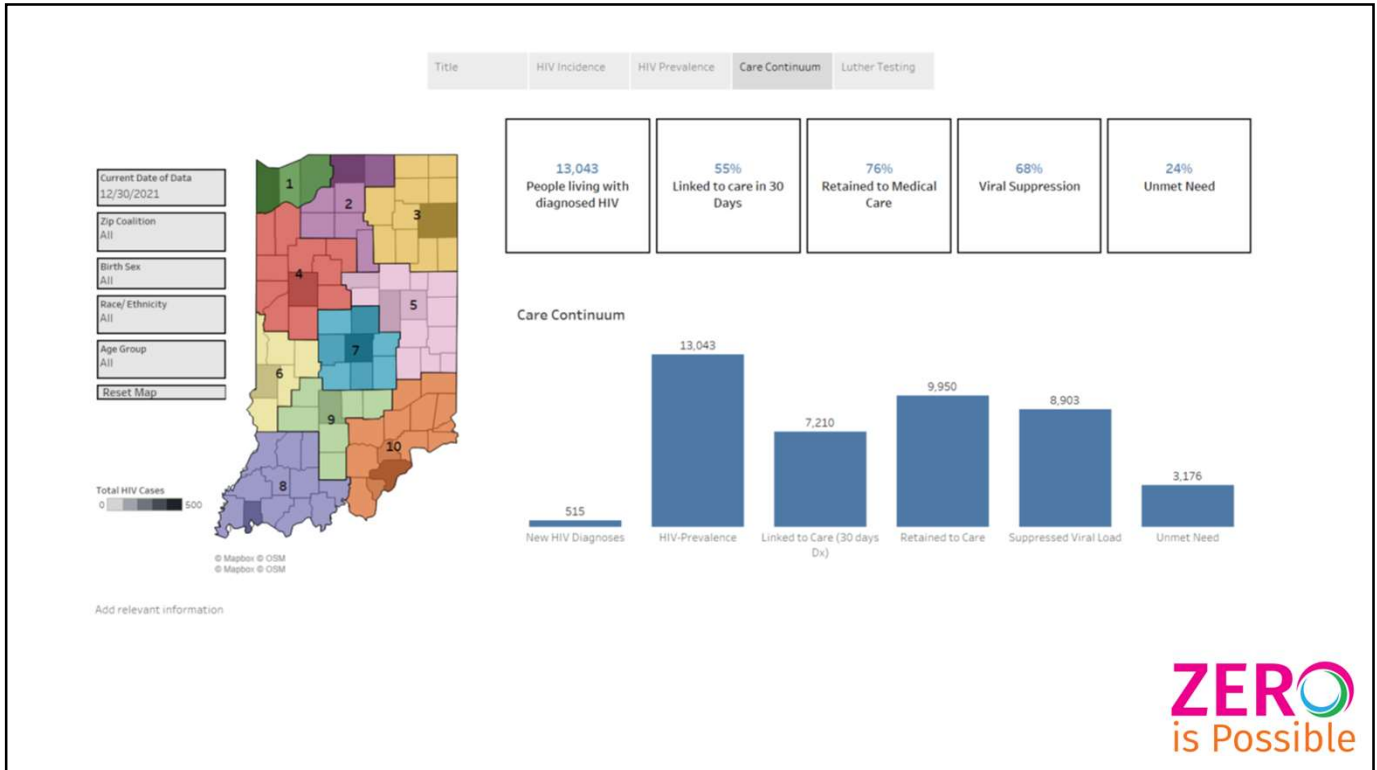
Designed to help ZIP Coalitions and individual organizations track, analyze, and utilize data for **improved program implementation and strengthening the system**.

Together, the **Regional Dashboards and Agency Scorecards** will help ZIP Coalitions:

- Understand **key populations** and **common modes of transmission**
- Support **policy, population** and **funding advocacy work** with **informed priorities**
- Strengthen **collaboration** and **knowledge sharing** between agencies
- **Monitor** and **evaluate progress** towards 10-year goals

Environmental Scan



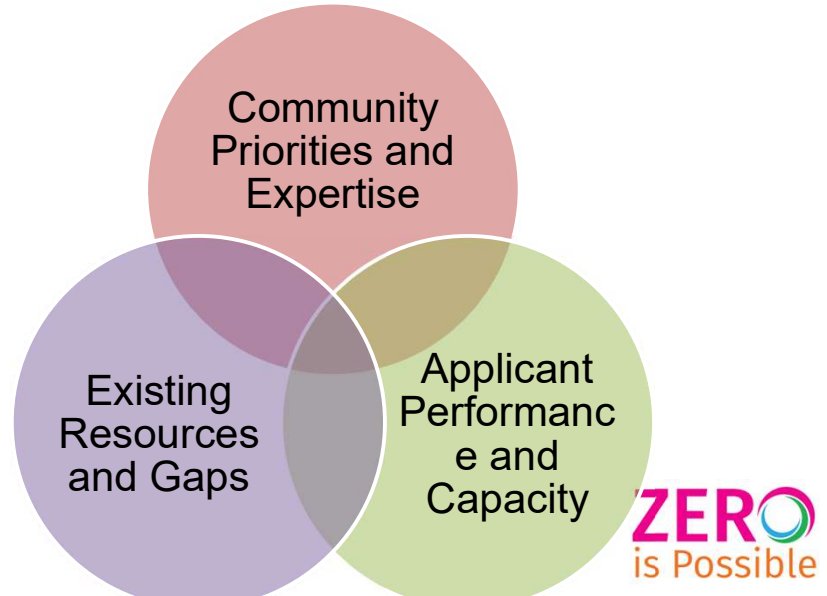
- Catalogue of regional resources to create a picture of what services are available to people living with HIV/Hepatitis

- Scan will be conducted yearly to update priorities and monitor

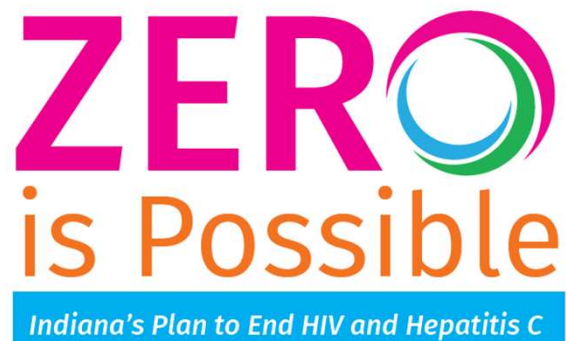

The Road to Elimination

- **Testing Recommendations**
 - Universal one-time testing for HIV
 - Once a year testing if higher risk
- **Pre-Exposure Prophylaxis (PrEP)**
- **Increase % of PLWH who know their status**
 - 87% aware in Indiana
- **HIV L2C Services**
- **Harm Reduction**

- **Screening Recommendations**
 - Universal one-time screening for hepatitis C
 - Screening for hepatitis C during each pregnancy
- **Vaccination for HAV and HBV**
- **Removal of Medicaid restrictions as of 10/1/2020**

 - Check Care Cure
- **VH L2C Services**
- **Harm Reduction**

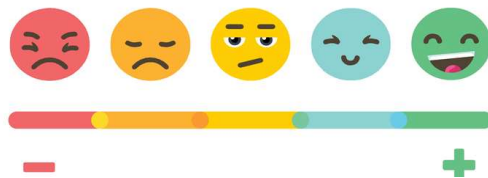
